According to UGC Act, 1956, the UGC has to ensure effective implementation of the Reservation Policy in Universities and Institutions receiving aid from the public funds except in Minority Institutions under Article 30(1) of the Constitution. All centrally funded Universities/colleges/Institutions are required to ensure strict compliance of Government of India orders/rules on the reservation in their institutions. State Universities including its affiliated/constituent colleges and other Institutes functioning within the State should follow the percentage of reservation for SC/ST & OBC as prescribed by the concerned State Government.

You are required to display the reservation roster which is to be updated at regular intervals on your web-site as per instructions issued by the Govt. of India, Dept. of Personnel & Training, New Delhi vide O.M. No.36012/2/96-Estt.(Res.) dated 2<sup>nd</sup> July, 1997.

You are also requested to fill up remaining backlog identified reserved vacancies under these categories in teaching and non-teaching posts. The UGC has circulated a letter No.F.1-5/2006(SCT) Central Educational Institutions (Reservation in dated 19-11-2012 to all Universities regarding Admission) Amendment Act, 2012 for compliance and necessary action as per the Gazette Notification 33. It is mandatory to furnish report along with statistical information in respect of teaching and nonteaching as well as admissions to all level courses and Hostel accommodation during the 2020-21 as per the prescribed format on the University Activity Monitoring Portal (UAMP) of UGC at following link https://ugc.ac.in/uamp/) .

The above instructions should also be circulated to all the constituent and affiliated colleges of your university for follow-up action please. faithfully.

#### Preface:-

As per the 103rd Amendment to the Constitution, Parliament has prescribed 10 per cent reservation for economically weaker sections in admissions to educational institutions and in government service appointments. According to the state government Hon. With the approval of the Cabinet vide reference no.1, 10 per cent reservation has been implemented for unreserved candidates (open category) for Economically Weaker Sections (EWS) in admissions to educational institutions in the state and in Government service appointments. For the benefit of the said reservation, the unreserved candidates (open category) who are not given the benefit of any backward class reservation in the state, economically weaker sections have been included.

The Maharashtra State Social and Educational Backward (SEBC) Class (for Admission to Educational Institutions in the State and Appointments or Posts in Public Services under State Control) Reservation Act, 2018 (Maharashtra of 2018) Candidates belonging to SEBC category in the State are not admissible for the benefit of EWS reservation as there is reservation without the provisions of Act No. 62). However, as the Central and State Government criteria regarding the



benefit of EWS reservation are different, the SEBC candidates in the Central Government services and admission to the EWS must satisfy the Central Government criteria. Regarding eligibility for the benefit of reservation, it has been informed under reference no.2. Also regarding EWS benefit to SEBC candidates in State Govt services and admissions reference no. Necessary instructions were given under 3 to 5.

Meanwhile Hon. As the Supreme Court has adjourned the SLP (C) No.15737/2019 vide interim order dated 09.09.2020, in the said case Hon. Considering the fact that the final decision of the Supreme Court is pending, taking into consideration the difficulties arising in the educational admission and recruitment process and also according to the decision in various court cases, Mr. As per the decision taken in the Cabinet meeting dated 23.12.2020, reference no. Under 6, candidates belonging to the Socially and Educationally Backward (SEBC) category have been approved for the academic admission for the year 2020-21 and issuance of Economically Weaker Sections (EWS) certificate for direct service recruitment. According to SEBC The benefit of unreserved posts (open category) or EWS reservation has been made optional for category candidates. Also, if the EWS reservation is availed, the said candidates will get SEBC. It was mentioned that the benefit of reservation for the category will not be admissible.


Hon. Supreme Court Civil Appeal No. 3123/2020 [SLP(C) No.15737/2019] SEBC vide final order dated 05.05.2021 in the matter. Since the reservation was invalidated, the SEBC Backward category reservation is applicable to the category candidates No. Hence SEBC category candidates are admissible for the benefit of unreserved posts. Reason If the said candidate belongs to the open category as per the government decision dated 12.2.2019 Economically weaker sections fulfilling the eligibility criteria for the benefit of reservation If any, they are allowed the benefit of reservation for economically weaker sections. Taking this matter into consideration. The matter of amending the Government decision dated 12.02.2019 is under consideration of the Government was Accordingly, the government takes the following decision regarding the reservation of economically weaker sections is -:

#### **Government Decision:**

Hon. Supreme Court Civil Appeal No. 3123/2020 In accordance with the decision regarding Socially and Educationally Backward (SEBC) reservation given on 05.05.2021, the following decision is being taken regarding reservation of economically weaker sections.

1) Government decision dated 12.2.2019 in reference no. 2 (a) (b) is being amended as follows.





(a) for the economically weaker section of the State whose castes include the Maharashtra State Public Service (Reservation for Scheduled Castes, Scheduled Tribes, Scheduled Tribes, (V.J.) Nomadic Tribes, Special Backward Classes and Other Backward Classes) Act, 2001 (Maharashtra of 2004 Act No. 8) 10% reservation is being prescribed in total admission seats in Government Educational Institutions / Aided Schools, Colleges, Educational Institutions, Unaided Schools, Colleges, Educational Institutions, Autonomous Universities for them not included in this. The said reservation shall not apply to minority institutions as referred to in Clause (1) of Article 30 of the State Constitution.

Also, 10% will be reserved for economically weaker sections for appointment in any cadre of direct service posts in Government Establishments, Semi-Government Establishment Boards / Corporations / Civil Local Self-Government / Rural Local Self-Government, Authorities.

- (b) This 10% reservation in the State is currently under the State Public Service (Reservation for Scheduled Castes, Scheduled Tribes, Scheduled Tribes, (V.J.) Nomadic Tribes, Special Backward Classes and Other Backward Classes) Act, 2001) (Maharashtra Act No. of 2004, of 8) shall be apart from the reservation for backward classes prescribed us.
- 2) The eligibility criteria and procedure for the benefit of reservation for economically weaker sections shall remain as per paragraph 2 (c) and 2 (d) of the Government Decision dated 12.2.2019. Annexure-A regarding the certificate referred to in paragraph 2 (c) (3) shall remain as annexed to the said Government Decision.
- 3) Except (4) in paragraph 2(e) of the Government Decision dated 12.2.2019, the other provisions shall remain in force as of 12.2.2019. The provision in paragraph (e) (4) is repealed.
- 4) EWS certificate should be issued on the basis of income and status of the previous financial year. Also the validity period of the certificate should be understood to be up to that financial year. Also, the validity period of the certificates issued during the period of 12.2.2019 to 31.3.2019 should be considered till March 2020.





Also, in cases where the selection process involves more than one stage or the selection process will be completed in the next financial year, it will be necessary to clearly mention the date of acceptance of the certificate in the advertisement.

- 5) As indicated under reference no.2, it is mandatory for the competent authority to issue a certificate in the pattern prescribed by the Central Government based on the criteria to be determined by the Central Government from time to time for direct service admission in the civil services and posts in the Central Government and for economically weaker sections for admission in educational institutions.
- 6) For SEBC category reference no. The orders passed under 3 to 5 should be considered cancelled.
- 7) S.E.B.C. The benefits given to the candidates under reference no.6 are maintained and SEBC Candidates eligible for EWS benefit can avail EWS reservation on the basis of prescribed certificate.
- 8) The benefit given to SEBC candidates from economically weaker sections under reference no.6 shall remain admissible as follows:-
- (i) The said benefit SEBC It will be applicable for the period from 9.9.2020 to 5.5.2021 from the interim suspension of reservation.
- (ii) In the case of the final results of the selection processes before 9.9.2020 but the appointments of the candidates are pending, the said order shall remain applicable with retrospective effect.
- (iii) the selection process which has been completed and SEBC. Such orders shall not be permissible in cases where appointments have been made under reservation.
- (iv) Candidates who have completed the selection process before 9.9.2020 and appeared as per appointment order and SEBC The above orders are not applicable in cases where the EWS certificate of the candidates has been invalidated.
- 9) The said order shall remain applicable for all further academic admissions.
- 10) Appointing authority / in case of doubt regarding the validity of Economically Weaker Element Eligibility Certificate, the said certificate should be verified accordingly by submitting an appeal as per paragraph 2 (d) 2 (i), (ii), (iii).



- 11) If suitable candidates are not available under the said reservation in the relevant recruitment year, they should be filled from the open category on the basis of merit without carrying forward the backlog of reservation.
- 12) This Government Decision applies to Government / Semi-Government Services, Boards / Corporations, Municipalities / Municipal Corporations, Zilla Parishads, Government Schools, Colleges, Government Educational Institutions, Private Schools, Colleges, Educational Institutions, Aided / Unaided Schools, Colleges and Educational Institutions and those who The right to issue directives to the State Government shall be applicable to all other authorities, services and institutions. Relevant agencies should issue necessary instructions in this regard.

Regarding reservation of seats for Socially and Educationally Backward (SEBC) classes including the Maratha community for admission in all non-agricultural university educational institutions in the state of Maharashtra...

## Maharashtra Government

#### Preface:-

An Act to provide for the advancement of Socially and Educationally Backward (SEBC) Class of Citizens in the State of Maharashtra for the reservation of seats for admission in the educational institutions of the State and for the reservation of appointments and posts in the public services under the control of the State and related or incidental matters under the above reference no.1 of the Government of Maharashtra. Published in the Gazette dated November 30, 2018. Issue No. in the said Act. 4 (1) (c), a total of 16% of the admission seats in aided and unaided educational institutions in the State are reserved for the Socially and Educationally Backward (SEBC) category of citizens including the Maratha community. Also reference no. 2 orders have been issued regarding reservation of 10% seats for admission in government services and educational institutions for economically weaker sections of open category in Maharashtra state. Also in the said government decision issue no. 4 All concerned departments are directed to issue necessary orders regarding admission to educational institutions forthwith. Pursuant to this, the department referred reference no. to reserve 16% seats for socially and educationally



backward (SEBC) classes including Maratha community and 10% seats for economically weaker sections of the open category for admission to all public non-agricultural university educational institutions except minority educational institutions in the state reference no. 3 Government circular has been issued on 08th March, 2019.

However, to further amend the Maharashtra State Reservation for Socially and Educationally Backward Classes (SEBC) (Seats for Admission in State Educational Institutions and Appointments and Posts in State Controlled Public Services) Act, 2018 vide above reference no. 4 of the Government of Maharashtra. Published in the Gazette dated July 3, 2019. Issue No. in the said Act. 2(c), instead of the total 16% of admissions in aided and unaided educational institutions in the State, 12% seats are reserved for the Socially and Educationally Backward (SEBC) category of citizens including the Maratha community. Pursuant to this, the Government was considering issuing a circular to instruct all non-agricultural universities under this department to reserve 12% seats for the Socially and Educationally Backward (SEBC) category of citizens for admission in educational institutions in the state of Maharashtra.

#### Government Circular:-

Above reference no. Pursuant to 4, instead of 16%, 12% seats should be reserved for the Socially and Educationally Backward (SEBC) class including the Maratha community for admission to educational institutions in all public non-agricultural universities in the State of Maharashtra.

- 2. 10% reservation of seats for economically weaker sections of open category will continue as indicated vide Government circular vide reference no.3.
- 3. The said reservation in admission to educational institutions as determined by the government will be applicable to all non-agricultural universities, recognized universities, law universities, self-financed universities, all aided and unaided colleges and autonomous colleges affiliated to them except minority educational institutions under the higher and technical education department of the state. It will be the responsibility of the respective universities to see that the said order is implemented effectively.
- 4. If the universities/institutions have prepared rules/regulations for admission in educational institutions and reservation for various social groups is shown therein, the concerned should immediately make the necessary amendments in those rules/regulations as per the prescribed procedure in accordance with this reservation.



5. All the universities are advised to bring the said circular to the notice of all the educational institutions under their jurisdiction.

## **Translated Version of Reservation Policy letter by University**

SUS/BCUD/Special cell /2015-16/3815

Dated. 22 July2015

#### Circular

Subject: regarding admission to all subjects/streams...

All affiliated colleges and department heads are hereby informed that the colleges should give admissions to UG and PG classes by following the rules and regulations timely directed by the university and the government. The colleges should mainly follow the terms regarding reservations given by the government strictly. It is seen that many colleges do not follow the rules of reservations given by the government. i.e., at the time of admission the colleges should follow the rules of reservation especially the ratio of percentage allotted for different categories given as below:

1	Schedule Caste	SC	13%
2	Schedule Tribe	ST	7%
3	Vimukta Caste -A	VJ-A	3%

6	Nomadic Tribe-D	NT-D	2%
7	Other Backward Class	OBC	19%
8	General	OPEN	50%

As per government rule/order for admission process, 50% seats should be allotted for General (OPEN) quota all 50% seats should be reserved for all backward classes. As per government rule GEC 1000 (12/03/2000) TS-1 Dated. 17/04/2000.

For UG admission 30% should be reserved for women students and 3% seats should be reserved for handicapped students.

#### Admission process/method as follows:

- 1) During the admission, the students from special backward class and other categories, the rules directed by the higher and technical department of the government are obligatory, under letter no. TES 3397/12926/ (9086) TS-1 Dated. 11 July 1997.
- 2) The categories which are under special backward classes that were earlier the part of other backward classes. The cast of the special backward class was the part of respected backward class should be considered of the related backward class only.
- 3) As per government rules 50% seats should be reserved for backward class. The said reservations should be as subject wise.
- 4) If the seat of any backward class/ category remain vacant during the admission process i.e. on merit bases, 2% of the vacant seat should be allotted to the students of the special backward class.

- 5) After allotment of 2% of seats to the special backward class, if the seats still remain vacant theses seats should be distributed among the backward categories equally.
- 6) The subject that does not have seat to fulfill all categories at that time the allotment should be done according to the chart given above , giving priority to SC,ST,VJ-A, NT-B,NT-C,NT-D and OBC in a sequence .
- 7) Unreserved posts suggested by the education department should be filled first. This list will also include backward class as per their merits. Such students should not be included in the list of categories. Remaining seats should be filled according to the reservation chart. During the admission process if the students from any category are not available then those seats should be from other backward classes following the government rules of interchangeability.
- 8) As per Maharashtra State Govt. reservation policy, creamy layer conditions are liable to all categories other than SC and ST.
- 9) Reservation facility / benefits are not liable to backward class candidate who are not the resident of Maharashtra State.
- 10) Care should be taken that the reservations should not exceed above 50% at any cost.

The affiliated colleges and the UG and PG departments in the campus should strictly follow the rules of reservation during admissions stated by the government and of the higher and technical education department references.

संसदेने संविधानात १०३ व्या घटनादुरूस्तीनुसार आर्थिकदृष्ट्या दुर्बल घटकांसाठी शैक्षणिक संस्थामध्ये प्रवेशासाठी व शासन सेवेतील नियुक्त्यांमध्ये १० टक्के आरक्षण विहित केलेले आहे. त्यानुसार राज्य शासनाने मा.मंत्रिमंडळाच्या मान्यतेने संदर्भ क्र.१ अन्वये अराखीव उमेदवारांकरीता (खुला प्रवर्ग) आर्थिकदृष्ट्या दुर्बल घटकांसाठी (ईडब्ल्यूएस) राज्यातील शैक्षणिक संस्थामध्ये प्रवेशासाठी व शासन सेवेतील नियुक्त्यांमध्ये १० टक्के आरक्षण लागू केले आहे. सदर आरक्षणाच्या लाभासाठी ज्या घटकांना राज्यात कोणत्याही मागास प्रवर्गातील आरक्षणाचा लाभ दिला जात नाही, अशा अराखीव उमेदवारांचा (खुला प्रवर्ग) आर्थिकदृष्ट्या दुर्बल घटकांचा समावेश करण्यात आला आहे.

राज्यातील शैक्षणिक संस्थामध्ये प्रवेशासाठी व शासन सेवेतील नियुक्त्यांमध्ये राज्यात सामाजिक व शैक्षणिक मागास (एसईबीसी) वर्गास " महाराष्ट्र राज्य सामाजिक आणि शैक्षणिक (एसईबीसी) वर्गाकरिता (राज्यातील शैक्षणिक संस्थांमधील जागांच्या प्रवेशाचे आणि राज्याच्या नियंत्रणाखालील लोकसेवांमधील नियुक्त्यांचे किंवा पदांचे) आरक्षण अधिनियम,२०१८ (सन २०१८ चा महाराष्ट्र अधिनियम क्रमांक ६२) " मधील तरतूदींन्वये आरक्षण असल्याने राज्यात एसईबीसी प्रवर्गातील उमेदवार ईडब्ल्यूएस आरक्षणाच्या लाभासाठी अनुज्ञेय नाहीत. तथापि, ईडब्ल्यूएस आरक्षणाच्या लाभाबावतचे केंद्र व राज्य शासनाचे निकष हे वेगवेगळे असल्याने केंद्र शासनाच्या सेवा व प्रवेश यामध्ये एसईबीसी उमेदवार हा केंद्र शासनाच्या निकषाच्या पूर्तता करुन ईडब्ल्यूएस

आरक्षणाचा लाभास पात्र असल्याबाबत संदर्भ क्र.२ अन्वये कळविण्यात आले आहे. तसेच राज्य शासनाच्या सेवा व प्रवेशात एसईबीसी उमेदवारास ईडब्ल्यूएस लाभाबाबत संदर्भ क्र. ३ ते ५ अन्वये आवश्यक सूचना देण्यात आल्या होत्या.

दरम्यान मा. सर्वोच्च न्यायालयाने एसएलपी (सी) नं.१५७३७/२०१९ मध्ये दि.०९.०९.२०२० रोजीच्या अंतरीम आदेशान्वये स्थिगती दिलेली असल्याने, सदर प्रकरणी मा.सर्वोच्च न्यायालयाचा अंतिम निर्णय प्रलंबित असल्याची बाब लक्षात घेता, शैक्षणिक प्रवेश व पदभरती प्रक्रिया यामध्ये उद्भवलेल्या अङचणी विचारात घेवून तसेच विविध न्यायालयीन प्रकरणी झालेल्या निर्णयानुसार मा.मंत्रिमंडळाच्या दिनांक २३.१२.२०२० रोजीच्या बैठकीत झालेल्या निर्णयानुसार, संदर्भ क्र. ६ अन्वये सामाजिक व शैक्षणिकदृष्ट्या मागास (एसईबीसी) वर्गातील उमेदवारांना सन २०२०-२१ या वर्षातील शैक्षणिक प्रवेश घेण्यासाठी व सरळसेवा भरतीकरीता आर्थिकदृष्ट्या दुर्बल घटकांचे (ईडब्ल्यूएस) प्रमाणपत्र देण्यास मान्यता देण्यात आली आहे. त्यानुसार एस.ई.बी.सी. प्रवर्गातील उमेदवारांना अराखीव पदांचा (खुला प्रवर्ग) अथवा ईडब्ल्यूएस आरक्षण हा लाभ ऐच्छिक ठेवण्यात आला आहे. तसेच ईडब्ल्यूएस आरक्षणाचा लाभ घेतल्यास सदर उमेदवारांस एस.ई.बी.सी. प्रवर्गासाठी असलेल्या आरक्षणाचा लाभ अनुज्ञेय रहाणार नसल्याबाबत नमूद करण्यात आले होते.

आता, मा .सर्वोच्च न्यायालयाने सिव्हिल अपिल नं. ३१२३/२०२० [एसएलपी (सी) नं.१५७३७/२०१९] प्रकरणी दिनांक ०५.०५.२०२१ रोजीच्या अंतिम आदेशान्वये एस.ई.बी.सी. आरक्षण अवैध ठरविले असल्याने ,एस.ई.बी.सी. प्रवर्गातील उमेदवारांना मागासवर्ग आरक्षण लागू नाही .त्यामुळे एस.ई.बी.सी प्रवर्गातील उमेदवार हे अराखीव पदांच्या लाभासाठी अनुज्ञेय आहेत. सबब सदर उमेदवार जर दि.१२.२.२०१९ रोजीचा शासन निर्णयानुसार खुल्या प्रवर्गातील आर्थिकदृष्ट्या दुर्बल घटक आरक्षणाच्या लाभासाठीच्या पात्रतेबाबतच्या निकषांची पूर्तता करत असतील तर त्यांना आर्थिक दुर्बल घटक आरक्षणाचा लाभ अनुज्ञेय आहे. सदर बाब विचारात घेता दि. १२.०२.२०१९ रोजीच्या शासन निर्णयात सुधारणा करण्याची बाब शासनाचे विचाराधीन होती.त्यानुसार शासन आर्थिकदृष्ट्या दुर्बल घटकांच्या आरक्षणाबाबत खालीलप्रमाणे निर्णय घेत आहे -:

- ४) ईडब्ल्यूएस प्रमाणपत्र हे मागील आर्थिक वर्षाच्या उत्पन्न व मत्ता या आधारे देण्यात यावे. तसेच प्रमाणपत्राच्या ग्राहयता कालावधी हा त्या आर्थिक वर्षापर्यंत समजण्यात यावा. तसेच दि.१२.२.२०१९ ते ३१.३.२०१९या कालावधीत निर्गमित करण्यात आलेल्या प्रमाणपत्रांचा ग्राहयता कालावधी मार्च २०२०पर्यंत समजण्यात यावा.

तसेच ज्या निवड प्रक्रियांमध्ये एक पेक्षा अधिक टप्पे समाविष्ट असतील अथवा निवड प्रक्रिया या पुढील आर्थिक वर्षामध्ये पूर्ण होणार असतील अशा प्रकरणी प्रमाणपत्राच्या ग्राहयतेबाबतचा दिनांक जाहिरातीमध्ये स्पष्ट नमूद करणे आवश्यक राहील.

- ५) संदर्भ क्र.२ अन्वये सूचित केल्यानुसार, केंद्र शासनामधील नागरी सेवा व पदे यामध्ये सरळसेवा प्रवेशासाठी व शैक्षणिक संस्थांमधील प्रवेशाकरीता आर्थिकदृष्टया दुर्बल घटकासाठी केंद्र शासन वेळोवेळी निश्चित करेल त्या निकषांच्या आधारे केंद्र शासनाने विहित केलेल्या नमुन्यात सक्षम प्राधिकाऱ्यांनी प्रमाणपत्र देणे बंधनकारक आहे.
- ६) एसईबीसी प्रवर्गासाठी संदर्भ क्र. ३ ते ५ अन्वये देण्यात आलेले आदेश रद्द समजण्यात यावे.
- ७) एस.ई.बी.सी. उमेदवारांना संदर्भ क्र.६ अन्वये देण्यात आलेले लाभ कायम ठेवण्यात येत असून एस.ई.बी.सी. उमेदवार ईडब्ल्यूएस लाभासाठी पात्र असल्यास त्यांना विहीत प्रमाणपत्राच्या आधारे ईडब्ल्रुएस आरक्षणाचा लाभ घेता येईल.
- ८) संदर्भ क्र.६ अन्वये एसईबीसी उमेदवारांना आर्थिकदृष्ट्या दुर्बल घटकांचा देण्यात आलेला लाभ खालीलप्रमाणे अनुज्ञेय राहील:-

- 99) संबंधित भरती वर्षात सदर आरक्षणांतर्गत सुयोग्य उमेदवार उपलब्ध न झाल्यास आरक्षणाचा अनुशेष पुढे न ओढता खुल्या प्रवर्गातून गुणवत्तेनुसार भरण्यात याव्यात.
